SHS Attendance Policy & Procedures

Spanish Honor Society meets on the **3rd Thursday of each month** at 7:05am. Please put this as a reminder on your phone or in your agenda.

Maintaining membership requires mandatory attendance at monthly meetings and participation in SHS activities/community services, as well as upholding the standards that are required for acceptance.

The SHS policy ensures that you are present at meetings so you can participate in society decisions, activities and requirements for membership.

Members of the society holding officer positions, may not run for the same officer position again. Their term is for one year.

Excused: Missing the day/morning of school with an excused note. A copy of the note from a Parent/Legal Guardian must be brought to Señora Corso.

Unexcused: No excuse note brought to Señora Corso. After two unexcused meetings, the student will receive a warning. After 3rd, the student will be removed from SHS.

Tardy: If a member shows up after the meeting has begun, they are considered tardy. If the tardy can be excused with a note, no further action will be taken. If not, a student with excessive tardies (more than 3), will face possible removal from SHS. If you are late and arrive as the meeting is ending, this is considered an **unexcused absence**.

NOTE

Valid excuses: doctor's appointment (with documentation), illness - not in school all day.

If you attend SCF, we still expect your attendance. If you cannot attend because of an early class, please show proof with your schedule.

Not valid excuses: Car trouble, slept in, no ride, had to take a test, etc. Meetings are always the 3rd Thursday of each month; therefore, you should plan accordingly.
